About YWCA Australia

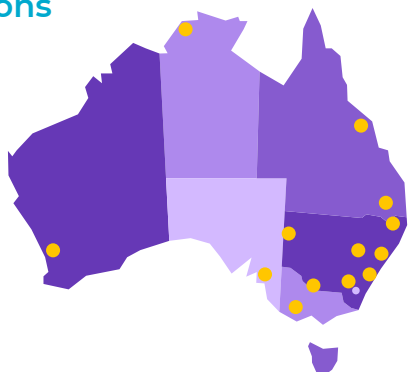

How to set up your workplace giving program

Step 1

Contact our Workplace Giving platform Good2Give at info@good2give.ngo or (02) 9929 9633 to create a free account.

Step 2

Share the YWCA Workplace Giving Registration Form with your employees to nominate that they would like to support YWCA through their pre-tax salary.

Step 3

Staff can nominate if they would like to receive information from us to receive updates directly about their support.
